**DENTIST BY CREDENTIALING:**

**Eric Buck, DDS PG (07:09)**

**MOTION (00:24:58)** Ms. Diedri Durocher moved to approve the Dentist by Credentialing non-routine application for Dr. Eric Buck, after a dental ethics course approved by the Board has been completed, Dr. Dale Chamberlain seconded.

**AMENDED MOTION (26:33)** Ms. Diedri Durocher amended her motion to include that it must be completed within 90 days of the next class

**AMENDED MOTION (41:44)** Ms. Diedri Durocher amended her motion to allow that it must be an in-person course that has been approved by the Board of Dentistry and completed within 6 months of the next class

**POINT OF CLARIFICATION (42:40)** Mr. Bradley Jones restated what the motion would be, that Dr. Bucks application for licensure be approved as a probationary license contingent upon the completion and submitting to the Board evidence of his completion of an in-person ethics course relevant to the practice of dentistry as recommended by MPAP. Conditions on licensure are based on violations to 37-1-316(16) failing to report the institution of a malpractice action, and 37-1-316(18) conduct that does not meet the generally accepted standards of practice. Also ARM 24.138.519(1)(b) misrepresentation of facts and information on application for licensure and reference 37-1-312(1) (d) making his continued licensure contingent upon satisfactory completion of a specific program of remedial education.

**AMENDED MOTION (54:23)** Ms. Diedri Durocher, to grant the application for licensure for Dr. Eric Buck with the stipulation that within 6 months he complete and offer proof of completion to the Department of Labor successful completion of an in-person ethics course as recommended by MPAP, Mr. Cliff Christenot seconded. Mr. Jim Corson opposed. The motion passed by majority.
